Notice of Service Charges for Regulatory Year ending 31 March 2026

Notice

In accordance with Condition 19.9 (a) of the Smart Meter Communication Licence (the "Licence") and Section J4.2 of the Smart Energy Code ("SEC"), Smart DCC Ltd ("DCC") hereby gives Notice to the Authority of DCC Service Charges for the Regulatory Year ending 31 March 2026 (RY 2025/26).

In accordance with Condition 19.5 of the Licence, DCC formally requests the Authority's approval of the form of the Charging Statement.

We explain the new Service Charges in the draft Charging Statement which is enclosed with this Notice. In accordance with Condition 19.13 of the Licence, we propose that this draft Charging Statement comes into effect on 1 April 2025.

A high-level summary of the other changes to for RY2025/26 compared to RY2024/25 are set out in Table 1 in Appendix A.

Please note that we have made allowances in this draft Charging Statement for Ofgem's draft decision on the RY2023/24 Price Control. We understand that Ofgem plans to publish its final decision in February/March 2025, and we will amend the draft Charging Statement if/when necessary before it takes effect in April 2025.

Next steps

A copy of the enclosed draft Charging Statement will be shared with those with whom DCC has entered into an Agreement for Services, pursuant to Licence Condition 19.9(b). Currently, this means all SEC Parties. We will also publish the document on our website.
